Dear Fellow Shareholders,

We are pleased to present the Fall 2021 Investor Update for Griffin Institutional Access® Credit Fund (the "Fund"). We greatly appreciate the support of our shareholders and will remain true to our stated investment objective of generating a return comprised of both current income and capital appreciation with an emphasis on current income with low volatility and low correlation to the broader markets.

We believe the Fund's sub-adviser, BCSF Advisors, LP, an affiliate of Bain Capital Credit, LP, has continued to construct a well-diversified alternative credit

portfolio. The portfolio composition is ultimately determined through both fundamental quantitative and qualitative analysis to determine what we believe is the optimal mix of securities across global markets with the potential to deliver the best risk-adjusted returns for investors.

#### Investment Performance and Positioning<sup>5</sup>

Griffin Institutional Access Credit Fund continued to deliver consistent returns and income in the trailing three-months ending August 31, 2021, posting a 1.81% total return (Class I Shares; NASDAQ: CRDIX), outperforming the S&P/LSTA Leveraged Loan Index by 0.98% during the period. The Fund also delivered strong performance over the trailing 12-month period ended August 31, 2021, during which the



Fund generated a total return (Class I Shares; NASDAQ: CRDIX) of 13.61%, outperforming the S&P/LSTA Leveraged Loan Index by 5.22% over the same period. All asset classes contributed to absolute returns during the period, demonstrating the power of active management. The Fund's loan portfolio in particular produced steady returns, delivering outperformance within all ratings segments. Within the Fund's liquid credit positions, selective exposure to Aerospace & Defense and Gaming & Leisure, two industries that were severely impacted during the pandemic, performed especially well and were among the top performers in the trailing three-months ending August 31, 2021. In addition, the Fund's exposure to portfolio companies that were restructured during the pandemic contributed to returns and have been a favorable source of total return for the portfolio. The Fund's CLO debt allocation also contributed positively to returns as the sector provided high income and spreads relative to other liquid portions of the alternative credit market. Lastly, the Fund's direct lending allocation generated attractive income for the Fund as private deals continued to offer spread pick-up relative to the syndicated markets.

From a positioning perspective, we remain constructive on the Fund's asset allocation in the current market environment. We recently increased the Fund's allocation to higher spread asset classes, such as structured credit and direct lending. Within structured credit, we increased the Fund's exposure to CLO mezzanine debt, primarily in the BB segment. We believe the BB segment may provide attractive carry with greater upside potential on a relative basis as bond and loan spreads have tightened. Additionally, we continue to be active participants in the direct lending market, deploying capital to new deals that offer attractive terms and spreads. Within the Fund's liquid credit portfolio, we continue to trim exposure to high-yield bonds, particularly in the higher quality BB segment, a reflection of our view on the potential path of interest rates and valuations in the bond market.

#### Market Overview and Outlook<sup>5</sup>

Alternative credit markets were positive in the three-month period ended August 31, 2021. High-yield bonds (as represented by the ICE BAML U.S. High Yield Index) were up 2.28%, outperforming loans (as represented by the S&P/LSTA Leveraged Loan Index) which were up 0.83% following a decline in interest rates amid easing concerns about potential upcoming Fed rate hikes. Though volatility has picked up in the market, lower quality and more COVID-sensitive sectors have continued to outperform in the current environment. For example, the Aerospace & Defense, Energy, and Media industries have broadly benefitted from the reopening and reflation in the economy, notwithstanding the emergence of the Delta variant.

The demand for alternative credit remains strong as evidenced by robust new issuance in bank loan and high-yield markets. Year to date through August 31, 2021, new loan issuance totaled \$601 billion, up 115% from a year ago. While supply has increased rapidly, demand has kept pace with record CLO issuance and consistent inflows into the asset class. At the end of August, default rates for loans and bonds were at 1.1%, continuing the sharp decline from the elevated default levels observed in 2020.

We believe the current market environment remains favorable for alternative credit and spread assets broadly due in part to the combination of strong economic activity, relatively accommodative financial conditions, low rates, and demand for

income. Consistent with the rise in COVID cases across the globe, we anticipate periodic pockets of volatility which, in our opinion, may provide more attractive entry points in the tradeable segments of alternative credit markets. In addition, we are closely monitoring macroeconomic trends and adjusting portfolio allocations accordingly as market participants continue to estimate the impact of rates and inflation moving forward. We believe the Fund is positioned well for an inflationary environment as we continue to emphasize income and maintain a preference for floating rate assets. Although liquid credit valuations have trended tighter in recent months, we remain generally constructive on the asset class and continue to be selective as it relates to industry and securities. Further, we remain favorably disposed to less liquid areas of the market, such as structured credit and direct lending as these opportunities offer potentially attractive risk-return profiles. The Fund's ability to be flexible and allocate across markets, industries, quality and asset class allows Bain Capital Credit to take a relative value approach and potentially capitalize on dispersion across markets. We are pleased with the Fund's current portfolio composition and continue to leverage the breadth of the Bain Capital Credit global platform to uncover investment opportunities consistent with the investment objective of the Fund.

## **GLOSSARY**

**Annualized Return:** Calculated by annualizing cumulative return (i.e., adjusting it for a period of one year). Annualized return includes capital appreciation and assumes a reinvestment of dividends and distributions.

**Basis Point:** One basis point is equal to 1/100th of a 1%, or 0.01%.

**Bloomberg Barclays U.S. Aggregate Bond Index:** An unmanaged index of domestic investment-grade bonds, including corporate, government and mortgage-backed securities.

**Bond:** A debt instrument, also considered a loan, that an investor makes to a corporation, government, federal agency or other organization (known as an issuer) in which the issuer typically agrees to pay the owner the amount of the face value of the bond on a future date, and to pay interest at a specified rate at regular intervals.

**Bond Rating:** A method of evaluating the quality and safety of a bond. This rating is based on an examination of the issuer's financial strength and the likelihood that it will be able to meet scheduled repayments. Ratings range from AAA (best) to D (worst). Bonds receiving a rating of BB or below are not considered investment grade because of the relative potential for issuer default.

**Collateralized Loan Obligation (CLO):** A structured credit security backed by a pool of bank loans, structured so there are several classes of bondholders with varying maturities, called tranches. Debt and equity securities of CLOs are sold in tranches where each CLO tranche has a different priority on distributions, unique risk exposures, and yield expectations based on the tranche's place in the capital structure. Distributions begin with the senior debt tranches (CLO debt) and flow down to the equity tranches (CLO equity).

**Correlation:** A statistical measure of how two securities move in relation to each other. A correlation ranges from -1 to 1. A positive correlation of 1 implies that as one security moves, either up or down, the other security will move in lockstep, in the same direction. A negative correlation of -1 indicates that the securities have moved in the opposite direction. If the correlation is 0, the movements of the securities are said to have no correlation; they are completely random.

**Cumulative Return:** The compound return of an investment. It includes capital appreciation and assumes a reinvestment of dividends and distributions.

**Duration:** A measure of how sensitive the price of a debt instrument (such as a bond) is to a change in interest rates and is measured in years.

**High-Yield Bond:** A bond issued by an issuer that is considered a credit risk by a Nationally Recognized Statistical Rating Organization, as indicated by a low bond rating (e.g., "Ba" or lower by Moody's Investors Services, or "BB" or below by Standard & Poor's Corporation). Because of this risk, a high-yield bond generally pays a higher return (yield) than a bond with an issuer that carries lower default risk. Also known as a "junk" bond.

**Mezzanine Debt:** Capital situated between senior secured debt and equity in an issuer's capital structure. The most senior debt has the first priority of claims in the event of a default while equity generally has the lowest priority of claims.

**Middle-Market Direct Lending:** A form of lending in which non-bank lenders loan money to mid-sized or middle-market companies. Middle-market companies are typically defined as those with earnings before interest, taxes, depreciation and amortization (EBITDA) between \$10 million and \$150 million.

**ICE Bank of America Merrill Lynch U.S. High Yield Index:** An index that measures the performance of below investment grade U.S. corporate bonds.

**S&P/LSTA Leveraged Loan Index:** A daily total return index that uses mark-to-market pricing to calculate market value change. It tracks, on a real-time basis, the current outstanding balance and spread over the London Interbank Offered Rate (LIBOR) for fully funded term loans. The facilities included in the LSTA represent a broad cross section of leveraged loans syndicated in the U.S.
